The process of analysis and exploration plays a significant role in the development of the volleyball game and has made it on the right track to upgrade high, and the loss of analysis and substantive assessment will result in a lack of knowledge of the difference in the level of the teams and players And then leads to skill weaknesses, and analysis is one of the important trainer tools to figure out the situation of each individual on his team and to find out why he has led to the team's weakness and not to a higher level.<sup>2</sup>The researchers said that analysis is one of the best ways to evaluate teams and players in order to find out the weaknesses of the team in subsequent tournaments, to know the strengths, to invest and focus them, as well as to show us the analysis Other variables have affected the difference and know the correlation between the results of the difference and the arrangement of the difference as well as the variation in the level between the teams participating in the Iraqi role championship in the volleyball of sitting men for the year of 2017.

It is well known that every failure has negative consequences, and that behind every accomplishment, good positive factors contribute to its realization and that winning any team at any tournament or rising from one stage to another does not come through coincidence, but through a long and arduous way of The training of the players and the team who wants to win the game in the volleyball from sitting it is investing as one of its players in order to score the most points to win the terms and then the games and that is only to prepare the players,<sup>3</sup> both according to his competence and training continuously and The aim and introduction of these exercises within the team's plans and this is only through continuous training on these plans and the detection of certain achievement cons and pros require analysis of all respects and the identification of weaknesses in order to overcome them and strengths to support them to any team through follow the matches of the teams and the results obtained in each game and in order to stand on all the variables that happened during the games and prepare and prepare the players to meet those variables by upgrading the performance according to the terms and conditions of the match and to be one of the researchers the Iraqi national team the plane of the sit-down found the fluctuating level of teams participating in the Iraqi volleyball tournament from sitting up and down, following the results of the Iraqi National Team and the problem of research is that the role of the team results in the games was not taken into consideration by our teams local in the volleyball game of sit up and the lack of a statistical specialist By most teams, there was a need to study the results of the teams, see the level of the teams involved and what to find out of the impact on the team's results to get the full results data.<sup>4</sup>

By informing the researchers about many of the games, they noticed that the results of the difference in the local championships did not receive much attention from the study and that there was a disparity in the level between the teams of the volleyball. Based on the above, the importance of research is reflected in the analysis of the results of the search sample teams to give a clear picture of the instructor and players about their level of performance and the relationship of that performance to the difference order.<sup>5</sup>

## II. METHODOLOGY OF THE RESEARCH AND ITS FIELD PROCEDURES

### Research method

Through the nature of the research problem, the researchers used the descriptive approach to the relational approach ((interested in detecting two or more variables to see the extent of the correlation between these variables and their digital expression)).<sup>6</sup>

### Community and research sample

The research sample was chosen intentionally by the teams participating in the Iraqi League in volleyball from the sitting for the year 2017 and the number (8) teams divided into two groups, group A included each of the teams (Al-Wissam, Diyala, Najaf, Kirkuk) and group B included both The difference (Dhi Qar, Maysan, Babil, and Wasit). Therefore, the total number of the research sample has reached (96) from the total volleyball players from sitting in Iraq, which number (192) are from (16) teams. Thus, the percentage of the research sample It is 50%, which is a representative percentage of society. The tournament was conducted in a group way, as the eight teams were divided into two groups and the sample was taken All of them are 100%, at the rate of three games for each team in the first round, as in table (1).

As for the team of the Kirkuk committee, it did not get any game in its three matches,<sup>7</sup> and lost the six games, and it has (79) points, and it has (150) points. The Dhi Qar committee team has (6) strokes and did not lose any stroke, and by (150) points, and it has 98 points. As for the Maysan Commission team, it did not get any stroke in its two matches, as it withdrew from the third matches in front of the Babylon Committee and lost the four halves that have it from the 29 points He has 100 points, and the Babel Committee team has actually won from the (1) stroke, and he has (4) strokes, and from the points he has 100 points, and he has 110 points. As for the Wasit committee team, it has (4) halves, and it has (3) halves, and it has (152) points, and (124) points.

points. As for the team of the Wasit Committee, which holds the fourth place, he got a run in the games that he lost with the Najaf Committee, and he has 81 points And it has (97) points.

Here, the researchers show through table (4) the results of the teams that have reached the final round, as well as the teams 'ranking in the championship and the number of matches they have fought, as the Golden Square teams' game has five games. The Al-Wissam club team won its five matches and its results were (0-2) in the first round and ( 0-3) in the semi-final and final round, while the Dhi Qar committee team won four games and its results were (0-2) in the first round and (1-3) in the semifinals and lost the final matches with a score of (0-3) against Al-Wisam Club (3 – 0), the Najaf committee team won two matches against the Kirkuk and Diyala committee and lost to the Al-Wisam Club in the first round and lost from the team of the Commission Dhi Qar in the semifinals and defeated the Wasit Committee team in the final round.<sup>8</sup> The Wasit Committee team won two matches against the Babylon and Maysan Committee, lost to Dhi Qar Committee in the first round and lost from the Al-Wissam Club team in the semi-final and lost from the Najaf Commission team in the final round, it came out of the first round and by three games for each team as in the first round schedule.

As for the Dhi Qar committee team, it has Of the (9) runs, he has (4) runs and from the points he has (286) points and has (255) points. And the Najaf committee team has from it (8), and it has (6) runs, and it has 315 points, and it has (271) points. As for the Wasit committee team, it has (5) runs, it has (9) runs, and it has (277) points, and it has 295 points. As for the teams that came out of The first round and played three games for each team, as it is the team of the Babylon Committee, which has stacks (3), and it has (4) runs, and it has (150) points, and it has (110) points, and the Diyala team has from the stakes (2), and it has (4) runs, and it has (99) points, (135) points, the Kirkuk committee team did not get any run in the three matches and lost the six games, and it has (79) points, and it has 150 points, as well as the Maysan committee team, so it did not get any run in the lost three quarters of the six points and has (29) points and the (150) points.



#### IV.DISCUSSION

By displaying the results in the previous table, which shows the results and the ranking of teams in the league, the Al-Wisam Club team ranked first on the first place in the level of performance, and the team of the Dhi Qar Commission ranked second on the second place, while the team of the Najaf Committee,<sup>9</sup> which ranked third, ranked third, and the Wasit Commission team, which ranked fourth, ranked fourth, and the team The Babylon Committee, in fifth place, ranked fifth, and the Diyala committee team ranked sixth in sixth place, and the seventh-ranking Kirkuk Commission team ranked seventh, and the team of Maysan Committee ranked last in eighth place, and the researchers attribute this to the ability of the medal players and Who constitutes most of his players from the members of the national team, so he possessed experience in diversifying the accuracy and accuracy of the results, which affected the reception of the rest of the teams.<sup>10</sup> The young woman, as most of the players were players of the national youth team, who showed a lack of clear experience in this team. As for the team of the Babylon Committee, the individual differences appeared in this team. As for Diyala team, it seemed clear the limited capabilities of its players.<sup>11</sup> As for the newly formed Kirkuk and Maysan teams, they came with beginners players in the Volleyball from sitting as weakness in the level of skills appeared clear to the rest of the teams as it appeared clearly weak training and coach, who was absent even the law of the game in most games.<sup>12</sup>

The psychological factor was also of great importance in maintaining the level or decline of players on the field, especially during the competition period, as the players will be subjected to a nervous tension caused by the level of the match as well as the audience, the referee and the stadium, that Psychological preparation is considered one of the basic requirements that qualify the player to perform these physical abilities at fixed rates and levels "as well as other aspects that affect the level of skillful performance of players on the field such as" the health aspect, satisfactory history ... etc.<sup>13</sup> These aspects must be taken care of as they are important in the game, in some Except depends on the players 'progress in training and winning matches.<sup>14</sup> The training of skills according to programmed and focused scientific foundations and according to the needs of each player leads to the development of the level of players in the performance of skills and then their obtaining advanced positions, in addition to the presence of distinguished players in the ranks of teams and among the national team players who have great experience in the field of the game.<sup>15</sup>

The weak levels with which the competing teams appeared within the championship have many reasons, including the failure to place players in a training program similar to the conditions of the matches with the presence of psychological and physical pressure on the players,<sup>16</sup> as well as a clear interest by the coaches in training these skills ((in order for everyone to carry out the tasks assigned to them on the field, he must be trained and master all the basic skills in volleyball)).<sup>17</sup> We cannot fail to mention that the poor performance of the teams and in various skills clearly affected the results of the teams.

#### V. CONCLUSION

Through the presentation, analysis and discussion of results, the researcher reached the following conclusions:

1. Most teams adopt an old training pattern that does not keep pace with the huge developments in modern volleyball skills and laws

2. Poor team fitness led to poor results and competition as well as other causes.
